

## River Oaks Golf League – 2026 Terms and Conditions

### Introduction

Participation in a River Oaks–hosted golf league represents a shared partnership between the player and the golf course. These Terms and Conditions outline the expectations, responsibilities, and operational procedures required for all league participants.

### Course Commitment

River Oaks agrees to:

- Provide quality course conditions throughout the league season.
- Administer fair, consistent games and competitions.
- Offer adequate prize selection and distribution.
- Maintain timely communication with league players via email and league software.

### Player Commitment

Players agree to:

- Follow all course policies, including etiquette and pace of play.
- Treat staff, fellow competitors, and course property with respect.
- Abide by all league rules, including the no-show policy.
- Adhere to the Terms and Conditions outlined below.

---

### 1. League Fees

- All players must pay the required league fee **prior to the first week of play**.
- Registration fees may be paid **online or in person**.
- **Phone payments are not accepted.**

---

### 2. Tee Times & Registration Priority

- Returning players from the previous season will receive a **pre-registration window** with first priority to secure a tee time.

- All players must complete the registration process before a tee time can be reserved for the season.

### **Tee Time Assignment Priority**

1. Previous season players
  2. Order of completed registration after the pre-registration window
- 

### **3. Handicap Requirement**

- All players must maintain an active **GHIN handicap** for fairness and equity.
  - River Oaks will provide access to GHIN services at a **discounted league rate of \$40**.
- 

### **4. No-Show Policy**

- League play includes **standing tee times**, and participation is expected weekly.
  - If a player cannot attend, they are responsible for securing a substitute.
  - A **credit card on file is required** for all league players.
  - A **\$15 no-show fee** will be charged when:
    - A player does not play **and** does not provide a substitute.

### **5. Check-In Requirements**

- All players must **check in prior to play each week**.
  - Substitutes are strongly encouraged and must:
    - Check in upon arrival
    - Inform staff which player they are replacing
- 

### **6. Inclement Weather Policies**

- River Oaks professional staff will determine postponements or cancellations and communicate decisions via email.
- If league play has begun and is later cancelled:

- Green and cart fees will be issued as **rainchecks**.
  - River Oaks reserves the right to **award league prizes** if a minimum of **9 holes** has been completed by all players.

## 7. Prizes & Club Credit

- All prizes will be issued as **Club Credit**.
  - Club Credit may be used for **in-stock merchandise only**.
  - Club Credit **expires October 31st** of the current season.
  - Club Credit **cannot** be used for:
    - Green fees
    - Cart fees
    - Range balls
    - Events
    - Food & beverage purchases

## 8. League Information & Results

- River Oaks will publish league games, rules, formats, and weekly results through an online league management system.
  - Players will have access to results both online and on the posted scoreboard within the Pro Shop.
  - Full league guidelines will be distributed before the first week of play.

## 9. Weekly Fees

- Players agree to pay all **green fees and cart fees** prior to each round.
  - Season Pass holders will be granted league-week green fee and cart fee privileges in accordance with their pass type.

## 10. Player Agreement
